 - * International Fire Code 2018 version
 - * International Fuel Gas Code 2018 version
 - * International Mechanical Code 2018 version
 - * International Plumbing Code 2018 version
 - * National Electric Code 2017 version

The estimated cost to purchase the updated codes is between \$1,500.00-\$2,500.00.

Waylon reported that all the new codes have been adopted, he needs the new books for the new codes.

Rhonda motioned that Waylon be allowed to purchase the new uniform codes that went into effect on September 14, 2021, by order of the Oklahoma Uniform Building Code Commission The estimated cost purchase should be between \$1,500 and \$2,500. Dollars.
