Applicant job duties include: manual work associated with repair/replacement of water meters and repair of water service lines; locates water meters; inspects accuracy/condition of meters and determines whether repair or replacement is most appropriate; installs/replaces broken, damaged, stolen, or missing water meters, backflow devices, and meter boxes; determines source of water leaks, makes necessary repairs, or refers more complex problems to work crews; lays/install pipes; replaces copper piping and fittings; checks pressure on water lines; flushes water lines to purify system; digs around meter boxes and removes dirt/debris; pumps water from meter boxes; repairs/replaces curb stops; shovels materials etc.

Applicant will tests meters to ensure proper operations, accurate readings, disconnects or reconnects water service to troubleshoot leaks and conduct repairs; locks/unlocks meters relating to non-payment of water accounts as needed.

This position requires ground work such as mowing, clearing roadways, road maintenance, operating heavy equipment, maintaining the Town Park grounds and more.

Applicant must be dependable and a hard worker. Applicant must be willing to work in all weather conditions.
